- The school will strictly adhere to all rules regarding safety of students including Fire fighting and Transportation, etc. Further, school will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys and 6. girls separately in proportion to the number of students. The school will ensure that Fire, Building, health and sanitation and safe
- Admission to the school is to be restricted as per relevant rules of Examination Bye-laws and rule 2.4.5, 2.6.5, 7.1, 7.2, 8.4.2, 7. 8.

- The school must strive to promote conservation of environment on their campus through rain water harvesting, segregation of waste at source, recycling of organic waste, proper disposal of waste including electronic waste, use of energy saving and energy efficient at source, recycling or organic waste, proper disposal or waste incloding electronic waste, use or energy saving and energy electrical equipment, greening of campus, use of solar energy, education and awareness amongst children on environment 12.

- no. affiliation-06/2018 dated 24.04.2018. Link for OASIS is available on Board's website:www.cbse.nic.in The optimum Section teacher ratio of 1:1.5 as well as student teacher ratio of 30:1 is to be maintained to teach various subjects and 13.
- school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board. Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinations from 14. 15.
- Every arminated school shall sponsor regularly its bollance and engine students in boards class x and class x11 examinations from the year mentioned while granting affiliation/up-gradation regularly without break or inform with reasons thereof in writing well in
- Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various examinations 16.
- The Manger and the Principal of the school shall be jointly responsible for the authenticity of the online/offline documents/ 17.

- The school shall be responsible for submission of any pending compliance, reply of show case /legal notice/ complaint and for 19. submission of date/information sought by the Board. The extension of 05 years shall be from the date of cessation of previous validity of extension of affiliation
- 20. The school is required to remit pending fee, if any
- The extension of affiliation is being granted as one time measure. However, the cases where the Show Cause Notice was 21. communicated or grievance / legal cases are pending against the school, the Board will take appropriate decision in this matter
- The school shall renew all mandatory safety certificate i.e Safe Drinking Water & Health and Hygiene certificate, Fire Safety 22. Certificate and Building Safety Certificate from concerned Govt authorities time to time
- The school shall also maintain record of certificate, compliances, data and other records/information and shall be fully responsible to produce all such records before Board and appropriate Government Authorities when asked for, failing which necessary action shall 23. be taken as per Affiliation-Bye-Laws of the Board. The school shall also be liable for action by the appropriate Govt., in case of violation / non-compliance of the concerned Govt. norms
